



Mind the Gap?

gap, *gap*, n. an opening or breach: a cleft: a passage: a breach of continuity. [O.N. *gap*.]

Autumn: the Michaelmas Term and “gaps” are in the air.

For many, there have been Gap-years and, inevitably, gaps in the onrush of academic learning: gaps too between “homes” old and new, between Sixth Form and University, between expectation and experience. Undergraduates are characteristically of an age at which GAP is as likely to suggest a clothes shop in the High Street as a shortfall in trade between imports and exports: a

rather the gap which justifies why we are fundraising at all. That is, the gap – perhaps soon to become a gulf – between the current cost of education and the ability or willingness of the State to meet such costs.

As the Master recently reminded those attending the Reunion Dinners: “Whether or not you agree with the idea of top-up fees, the fact that they are being discussed at all is an explicit recognition that there is a problem: a growing differential between the cost of providing a first class University education and the resources which the State makes available to cover such costs.”

At Magdalene, we remain determined that, whatever the costs of such provision, we will neither dilute the quality of what we offer, nor

recognition which prompts some of us to realise that we are now on the wrong side of another gap: the generation gap for which we once thought our parents exclusively responsible. Amongst the Fellowship there is talk of the gap in perception between what the College and the University are actually doing and how that is interpreted by Government or portrayed in the press; whilst, more generally, the news is filled with evidence – when was it not – of the development gap: the widening breach between rich and poor. For an international community like Magdalene’s that too has its local as well as its global resonances. Gaps then, like breaches in a Fenland flood, to the left, right and centre.

However, those most closely involved in the Campaign might be forgiven for dwelling on a Development gap still nearer to home: no, not the obvious one between the Campaign’s target and our current achievement, but

restrict access to it only to those with the ability to pay. It is our resolve to achieve these ambitions which gives both force and urgency to the twin priorities of the Magdalene Campaign: firstly, to make good the shortfall in State funding in order that we can plan for the future confident that we have the financial means to determine our own destiny; and secondly to build up our resources to support, through Access and Scholarship Bursaries, students in hardship. Only by offering such support can the College pursue a needs-blind admissions policy which ensures that those with the ability to come to Magdalene are not denied a place on financial grounds. These two objectives have always been at the Campaign’s heart and will continue to be so. In short, minding the gap must not mean that the doors are closing; rather that the College is moving forward and in the right direction.

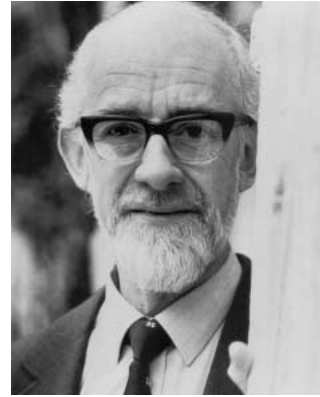

FOUR RETIREMENTS AND AN ARRIVAL



The St Mary Magdalene meeting of the Governing Body in July saw the retirement of four of the College’s senior Fellows: Ronald Hyam, Peter Reynolds, Colin Kolbert and John Field. Ronald Hyam and Peter Reynolds share the distinction – unrivalled in the College’s history – of serving under no less than six Masters. Ronald subsequently noted that, in the course of this marathon, he had attended some 378 meetings of the Governing Body; whilst, between them –

as variously Tutors, Directors of Studies and Librarian – the four retirees accumulated 152 years in the College’s service. We wish them all well. The October meeting of the Governing Body saw some redress: the admission to a Fellowship of Dr Allègre Hadida. Dr Hadida (seen being welcomed by the Master) is a University Lecturer at the Judge Institute and a specialist in strategic management particularly in the field of arts and culture.



Give as you Earn

As some of our benefactors already know, the Government has been promoting payroll giving (known as Give As You Earn) as a tax-efficient method of donation. The idea is to make more people employed in the UK aware of the benefits of regular donations to charity. To encourage new donors, the Treasury has announced that, until April 2004, it will “top-up” any donations to charity made through payroll giving by 10% of the gift value. Anyone who is an employee or a pensioner can give through GAYE provided that his/her employer deducts PAYE tax from pay or pension. Donations are deducted from pay (or

pension) before PAYE is calculated, which means that tax relief is given immediately at the individual’s highest tax rate. For higher-tax payers this presents a particularly attractive opportunity, see table for example.

Magdalene already has some donors who give in this way. However, we would like to take full advantage of the present arrangement by encouraging anyone who is thinking of giving to the College for the first time to do so through their payroll scheme if possible. New Scholarship Bursaries

Amongst the 104 freshers matriculating in October this year were the first Philip Carne and Jack Vettriano Scholars. Philip (1958), a member of the Campaign Committee, established his Scholarship

Scheme with a major gift. He told *Magdalene Matters*: "I decided to support the College in this way because I think it is important that we encourage applications to Magdalene from bright students from poor families who might otherwise be deterred from applying because of financial constraints. If I can help to enable this it will give me considerable satisfaction."

Jack Vettriano OBE is a distinguished and highly successful artist whose work is to be seen in a variety of locations worldwide. Introduced to the College by Tom Hewlett (1971) Jack was moved to fund his Scholarship because: "The owner of the art gallery which represents me was a Magdalene undergraduate in the early 1970's. Through him I learned that the College was trying to raise funds to offer financial support to students from backgrounds very similar to my own. I therefore felt that this was a cause

to which I would like to contribute." Jack has accepted Honorary Membership of the College which will be conferred in November when he comes to Cambridge.
